STAFF RECOMMENDATION:

This item is for the Committee to:

1) Conduct a public hearing to receive comments on transit needs in Riverside County (County).

BACKGROUND INFORMATION:

The California State Transportation Development Act (TDA) requires that transportation planning agencies ensure the establishment of a citizens' participation process for each county. This process includes an element in which the California Public Utilities Code (PUC) Section 99238.5 states, "The transportation planning agency shall ensure the establishment and implementation of a citizen participation process appropriate for each county. The process shall include a provision for at least one public hearing in the jurisdiction represented by the social services transportation advisory council."

The purpose of the public hearing is to garner public participation and solicit input from transit dependent and transit disadvantaged persons, including the elderly, disabled and persons of limited means. The CSTAC fulfills the citizens advisory council and the social services transportation advisory council TDA requirements. It consists of up to 13 members of the public and two Consolidated Transportation Service Agency members from Riverside Transit Agency and SunLine Transit Agency. The committee assists the Commission in fulfilling TDA regulations by promoting transportation service improvements and enhancements that support the mobility of older adults, persons with disabilities, and persons of limited means. It also establishes an effective communication exchange among the County's public transit operators, local specialized transit providers, and representatives from diverse transit dependent populations regarding matters of mutual concern.

The public hearing was advertised by transit operators, specialized transit providers, and other stakeholders on buses, facilities, and social media (Attachment 1). Staff also published a 30-day hearing notice in English and Spanish in the major newspapers throughout the County including *The Press-Enterprise, The Desert Sun,* and *The Palo Verde Times*. STAFF RECOMMENDATION:

This item is for the Committee to:

1) Receive and file presentations from Measure A Specialized Recipients, the Exceed and Forest Folk.

BACKGROUND INFORMATION:

The 2009 Measure A Expenditure Plan allocates approximately 11.6 percent of the annual revenues from the 2009 Measure A Western County program to public transit. The public transit allocation is then distributed among five programs, namely: specialized transit services, specialized transit-consolidated transportation service agency operations, commuter rail, intercity bus, and commuter services. The Measure A Specialized Transit Program receives about 1.9 percent of the 2009 Measure A Western County program revenues, or a 16.4 percent share of the 11.6 percent for public transit. The program provides funding to benefit older adults, persons with disabilities, and/or those that are most vulnerable and truly needy in Western County. In Western County, this funding has been distributed through a competitive process to a wide array of non-profit and community organizations that serve these constituencies for specialized transit services for persons with disabilities and older adults.

The goals of the Measure A Specialized Transit Program for western Riverside County are to:

- Support directly operated services that expand or extend existing services, which, if not funded by Measure A funds, would leave an area and/or special population without alternate service options;
- Support existing services that offer an improved level of service coordination with the existing transportation network;
- Expand new services that leverage other revenue sources, can be administered in a costeffective manner, and will not require long-term support from Measure A funding; and
- Support new and expansion of existing services including transportation for veterans and shuttles including, but not limited to, nutrition and medical services.

Projects that are eligible under the program include operating and capital projects such as senior transportation shuttles, non-emergency medical transportation services, bus pass/voucher programs, mileage reimbursement programs, travel training, vehicle and maintenance equipment, communications and dispatch equipment, and mobility management.

Providing funding to non-profit providers of transit services for persons with disabilities, low income, and senior citizens has long been a priority of the Commission. The voter-approved 1989 and 2009 Measure A Expenditure Plans specify funding allocations for the provision of this type of service provided by transit operators and non-profit agencies.

A Call for Projects is held triennially, and the current Call for Projects was held in spring 2024 for funding for Fiscal Years (FY) 2024/25 - 2026/27. The Commission awarded \$9,945,987 to 15 agencies for 20 operational and capital projects, as summarized in Attachment 1.

The specialized transit services are promoted countywide with social service agencies and at public offices such as senior centers, libraries, community centers, cities, colleges, and public bus operators. For this cycle, RCTC plans to distribute approximately 12,000 brochures. This includes 6,000 in English and 6,000 in Spanish.

DISCUSSION:

The CSTAC plays an important role in strengthening the public and specialized transit network by offering a platform for specialized transit providers to share information and promote various transportation services. Staff has invited Measure A recipients to provide presentations to the CSTAC to highlight their programs and projects and receive any input on how their services can be improved and expanded in the future.

Presentations from the EXCEED and Forest Folk will be given (Attachments 2 and 3). EXCEED has been in the Measure A Specialized Transit Program for 6 years. In FY 2023/24, EXCEED supported 32,844 one-way passenger trips with a budget of \$324,625. Forest Folk has been in the Measure A Specialized Transit Program for over 15 years. In FY 2023/24, Forest Folk provided 2,779 one-way passenger trips with a cost of \$98,693.




Transportation At-a-Glance



Individuals that have unique medical conditions, seizure disorders and cognitive disabilities require personalized care. Medically frail clients cannot tolerate extremes in temperature or extended exposure to sunlight while waiting. Clients with seizure disorders may need some level of continuous supervision and someone with training in seizure disorders to accompany/drive them. Developmental disabilities may not allow a rider to recognize their bus stop or be able to articulate their address and/or phone number to a driver, especially to someone they do not know or are not familiar with. Additionally, they may become agitated, fearful, or experience severe anxiety under certain conditions.

STAFF RECOMMENDATION:

This item is for the Committee to:

1) Receive and file an update on the Coordinated Public Transit-Human Services Transportation Plan (Coordinated Plan).

BACKGROUND INFORMATION:

The Coordinated Plan documents the mobility needs and gaps of seniors, persons with disabilities, persons of low-income, and veterans living and traveling in Riverside County (County). The Coordinated Plan serves two purposes: fulfills the requirements to receive funding through the Federal Transit Administration (FTA) Section 5310, Enhanced Mobility of Seniors and Individuals with Disabilities Program; and is utilized to identify projects for the Commission's Measure A Specialized Transit Triennial Call for Projects.

The Commission's first Coordinated Plan was approved in April 2008 as was required under the federal *Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users* (SAFETEA-LU) to receive funds to enhance mobility options for job access and reverse commutes, and seniors and individuals with disabilities. Since SAFETEA-LU, the requirement for a coordinated planning process was reaffirmed under the federal transportation bill, Moving Ahead for Progress in the 21st Century (MAP-21), Fixing America's Surface Transportation Act (FAST Act), and the current Infrastructure Investment and Jobs Act (IIJA) passed in 2021.

With the approval of the 2008 Coordinated Plan, the Commission also adopted a strategy for developing and conducting a specialized transit call for projects for western Riverside County. This process was intended to be used to competitively disburse Measure A Specialized Transit funds to qualified non-profit providers and public operators whose projects are consistent with strategies identified in the Coordinated Plan. Since that time, the Commission approved and awarded funds from seven separate call for projects.

DISCUSSION:

FTA Circular 9070.1G requires that the Coordinated Plan be developed and approved through a process that includes participation by seniors, individuals with disabilities, representatives of public, private and nonprofit transportation and human services providers, and other members of the public (e.g., veterans, persons of low-income, etc.).

RCTC is utilizing AMMA Transit Planning (AMMA) to assist in the development of the Coordinated Plan. The development of the Coordinated Plan will be broken out into the following four different phases of work:

- 1) Existing Conditions Assessment
- 2) Stakeholder Engagement
- 3) Developing Recommendations and Strategies
- 4) Draft and Final Coordinated Plan

The first phase requires an assessment of available transportation services and identification of the needs and gaps in the current transportation network and will include a geographic and demographic analysis of the specialized target populations. The second phase will include stakeholder engagement such as interviews, focus groups, surveys, and community meetings with transit riders and public and social service agencies that provide transportation services to better understand the challenges and opportunities they face in accessing or delivering transit services across the county. Recommendations and strategies will then be developed and prioritized to address gaps and needs and opportunities to enhance the capacity of services. The final Coordinated Plan will summarize each phase and be brought to the CSTAC and Commission in late spring 2025 for approval.

The Citizens and Specialized Transit Advisory Committee's (CSTAC's) input and partnership in the Coordinated Plan is needed and encouraged. CSTAC members will be able to participate in agency stakeholder meetings, focus groups, and community surveys. Additionally, we encourage CSTAC members to share with their networks information on potential public meetings and surveys. More information will be provided to the CSTAC members regarding their participation for the Coordinated Plan update between the fall of 2024 through spring of 2025 timeframe.
