Nightly full closures of eastbound 91 are scheduled for the week of July 15, 2024.

Additional nightly eastbound and westbound alternating lane closures, Express Lanes closures, connector closures, and ramp closures are also scheduled throughout the week.

Upcoming Nightly Full Closures of Eastbound 91

The Riverside County Transportation Commission's 71/91 Interchange Project will require nightly full closures (Monday through Wednesday) of eastbound 91 beginning **Monday, July 15, 2024.** These closures are scheduled to occur through mid-August.



RCTC Traffic Relief Plan



Approved by the Riverside County Transportation Commission (RCTC) on April 10, 2024, the Traffic Relief Plan outlines aspirational transportation solutions in Riverside County for Riverside County residents.

The updated Plan identifies the need to invest in crucial transportation projects, services, and infrastructure, including public transportation, roadway safety, highway improvements, active transportation, securing infrastructure from natural disasters, and environmental mitigation.

Project Background

The new non-tolled interchange is designed to improve safety, expand access to other modes of travel, reduce greenhouse gas emissions, enhance traffic flow, and support continued movement of native wildlife through the area. Construction is anticipated to be completed in 2025.
