Full Weeknight Closures of Westbound 91 Continue

Full weeknight (Monday – Wednesday) closures of westbound 91 between the 71 and Green River Rd. in Corona continue. Closures are scheduled through Wednesday, December 18, 2024.



Nighttime Full Closure of Southbound 71 – Thursday, December 12

A nighttime full closure of southbound 71 at Butterfield Ranch Rd./ Euclid Ave. in Chino and Chino Hills is scheduled for **Thursday, December 12, from 9 p.m. – 5 a.m.** for crews to perform a concrete pour on a new section of the connector.


Neighboring Projects
